Make the check payable to Lushena Books.
3. Baker And Taylor-Needs Authorization from Publisher-(This is done by setting up Lushena as your distributor through Bowkerlink.com, detailed instructions will be email to you) **No fee**

6. Independent retail stores

DISTRIBUTION POLICY

The distribution terms of Lushena Books Inc. are as follow:

1. Lushena Books Inc. requests 60% discount off the retail price of the title/s. Example. If an item's retail price is \$10.00, Lushena will pay the publisher \$4.00 for every copy sold. **PUBLISHING COMPANY WILL PAY THE SHIPPING CHARGES WHEN SENDING ITEMS TO LUSHENA BOOKS. SHOULD THE PUBLISHING COMPANY REQUEST ITEMS TO BE SENT BACK, THEY WE BE AT THEIR EXPENSE, THIS AMOUNT WILL BE DEBITED FROM THE ACCOUNT BALANCE, OF IF THERE IS NO BALANCE THEN IT WILL BE CHARGED TO A CREDIT CARD.**

2. Lushena Books Inc. requests 30 days Net. At the end of 30 days, Lushena Books Inc will provide an inventory status of the titles and remit payments for books sold to independent retail stores, web sales and mail order sales. The first payment will be made 30 days after original receipt date, and at the end of that month. Please note that you will only receive payment for said orders.
3. **Books sold to Barnes and Noble, Ingram and Baker and Taylor and Amazon will be paid for 121 days from the date the invoice – this is 1 day after these companies pay us.**
4. If Publisher/Author agrees to these terms and would like Lushena Books Inc. to distribute his/her title/titles the Lushena Books Inc. requires the following information, **you must submit your title at:**

 - (c) Retail Price
 - (d) Case Quantity
 - (e) Name, address, telephone, Email, and contact information of Publisher of book
 - (f) Name and address, telephone, email and contact **information of Payee**
 - (g) Date of Publication
 - (h) **Sample Copy-Lushena Books must receive 1 desk copy for submission to Barnes and Noble; this can either be mailed separately or included in our first purchase order. Plus another sample copy for Lushena Books internal use.**
 - (i) **A copy of the Marketing Plan for your company, your title will not be submitted to Barnes and Noble until this is received.**
 - (j) **Please fill out and sign this document, fax it to 630-238-8824, your title will not be added to Ingram and Baker and Taylor database until this procedure is done.**
